Entitlement to a Canadian Passport

- Issued to Canadian citizens only, Canadian passports reflect the identity of the applicant as determined by documentary evidence of citizenship and supplementary documentation.
- Persons 16 years of age or over must use this form (PPT 044) to apply.
- Children under 16 years of age must have an individual passport (use form PPT 046 "Child Passport Application").

Applying in Person



DO NOT mail or use courier services to send your application form to a local passport office.

Our goal is to have the passport ready in **10 working days**.

Requirements



CHECKLIST

- All **THREE** pages of the application form completed and signed.
- TWO** identical passport photos taken within the last 12 months.
- Application form and one of the photos certified by my guarantor.
- Original proof of Canadian citizenship (no copies or notarized copies).
- Documents to support identity.
- Any Canadian passport or travel document issued to me within the last **FIVE** years.
- The fee.

Additional documents or information may be requested in support of the application.

Failure to provide all information will delay issuance of the passport.

Personal information provided on your application form is protected and used in accordance with the provisions of the *Privacy Act* (Personal Information Bank No. FAI PPU 030).

This information is collected under the *Canadian Passport Order* (SI/81-86) and the *Order Amending the Canadian Passport Order* (SI/2001-121) to determine your current and ongoing entitlement to a Canadian passport and to provide information to the Consular Affairs Bureau of the Department of Foreign Affairs and International Trade in the event that you require assistance while travelling abroad. The information provided may be verified.

General information is available 24 hours a day, 365 days a year. Specific information is available during regular office hours. Application forms are available in Braille, on diskette or in large print for persons with a visual impairment.

Personal Information

NAME TO APPEAR IN PASSPORT

Write the name you want to appear in the passport. If this name is different from the name on your documentary evidence of citizenship, the original of the documentation listed below may be required:

- Marriage certificate;
- Legal change of name (original document from issuing authority).

Additional documentation will be required to verify your identity as well as the name to appear in the passport (*see instruction No. 5 "Documents to Support Identity"*).

SURNAME AT BIRTH/FORMER SURNAME

Complete only if different from the surname to appear in the passport (for Passport Office information only; will not appear in the passport).

ADDING A SPOUSAL SURNAME TO A VALID PASSPORT

Your spouse's surname may be added to a valid passport provided the passport was issued in your surname at birth and the marriage occurred after the issuance of the passport. A marriage certificate or additional documentation will be required.

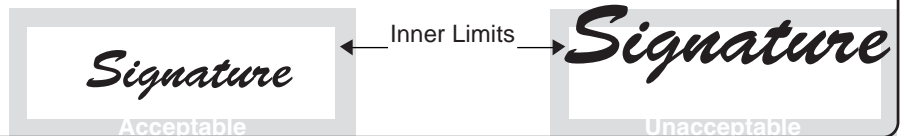
The fee for this service is \$12.

PLACE OF BIRTH

Your place of birth must be provided on the application form. If you do not wish the place of birth to appear in the passport, submit a written request. Be sure to contact the consulate or embassy of every country you plan to visit to ensure that you will be admitted if the passport does not include your place of birth.

SIGNATURE

You **MUST** sign your usual signature on all **THREE** pages. Your signature **MUST NOT** exceed the inner limits of the signature box.

Declaration of Guarantor

A guarantor is a person who confirms your identity. Your guarantor must perform **free of charge** the following **THREE** tasks:

1. Certify the information on your application form by completing and signing the "Declaration of Guarantor" section;
2. Write on the back of **ONE** of your photos, "I certify this to be a true likeness of (*your name*)" and sign;
3. If applicable, sign and date a photocopy of your supplementary documentation (*see instruction No. 5 "Documents to Support Identity"*).

Your guarantor must:

- be a Canadian citizen residing in Canada and must be accessible to the Passport Office for verification;
- have known you personally for at least **TWO** years and well enough to be confident that the statements you have made in your application form are true;
- sign the "Declaration of Guarantor" section on your application form;
- sign the statement on the back of **ONE** of your photos; and
- be included in **ONE** of the following groups:
 - dentist, medical doctor or chiropractor
 - judge, magistrate, police officer (municipal, provincial or RCMP)
 - lawyer (member of a provincial bar association)
 - mayor
 - minister of religion authorized under provincial law to perform marriages
 - notary public
 - optometrist
 - pharmacist
 - postmaster
 - principal of primary or secondary school
 - professional accountant (member of APA, CA, CGA, CMA, PA or RPA)
 - professional engineer (P. Eng., Eng. in Quebec)
 - senior administrator in a community college (includes CEGEPs)
 - senior administrator or teacher in a university
 - veterinarian.

The list above is not a recognition or endorsement by the Passport Office of professional status or superior qualifications.

If you have **not known** an eligible guarantor for at least **TWO** years, complete a "Declaration in Lieu of Guarantor" form PPT 132, available from any passport office. This form must be completed at your expense before a person authorized by law to administer an oath or solemn affirmation. **This may delay the processing time of the passport.**

Previous Canadian Passport

- Enclose any Canadian passport or travel document issued to you within the last **FIVE** years.
- A person's name may appear in only **ONE** valid Canadian Passport, Certificate of Identity or Refugee Travel Document.
- Passports are valid for a maximum of **FIVE** years from the date of issue. If, under exceptional circumstances, a limited validity passport was issued to you within the last **FIVE** years, it may be extended. The fee for this service is \$12.
- If the valid passport has been lost, stolen, damaged, destroyed or is inaccessible, complete "Statutory Declaration" form PPT 203, available from any passport office.

Proof of Canadian Citizenship

Provide **ONE** of the documents listed in section 4 of the application form (copies or notarized copies are not accepted). It will be returned to you with the passport. Additional information may be requested to confirm your citizenship. If you are a woman who, before 1947, married a man who was not a British subject, contact the Passport Office.

CERTIFICATE OF BIRTH IN CANADA

You may obtain a birth certificate from the Vital Statistics authorities of your province or territory of birth.

NEW If you were born in Quebec

Only birth certificates issued on or after January 1, 1994, by *Le Directeur de l'état civil* in the province of Quebec are accepted.

CERTIFICATE OF CANADIAN CITIZENSHIP

Large commemorative documents of citizenship issued after February 14, 1977, are **not** accepted. If you require a Certificate of Canadian Citizenship, contact the office of the Registrar of Canadian Citizenship:

Documents to Support Identity

At least **ONE** document to support your identity and the name to appear in the passport must be submitted with your application form. Further documentation may be required.

Supplementary documentation must be issued by a federal, provincial or municipal authority and include the bearer's name and signature. For example:

- Provincial driver's licence
- Provincial health care card
- Other provincial identification card
- Certificate of Indian Status
- Firearms Licence - Possession • Acquisition
- Old Age Security card
- Other federal identification card
- Federal, provincial or municipal employee identification card.

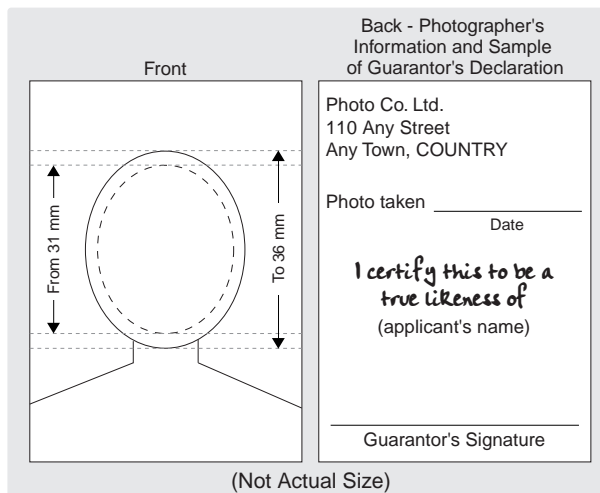
You may submit original documents. They will be returned to you. If you are submitting photocopies, your guarantor must sign and date the photocopies to indicate the originals have been seen.

If you are submitting photocopies but are using form PPT 132, "Statutory Declaration in Lieu of Guarantor", the same official who signs the "Declaration" must also sign and date the photocopies of your identification to indicate the originals have been seen.

If you have no documents to support your identity, call the Passport Office.

Photo Specifications

- **SIZE:** 50 mm X 70 mm (2 inches X 2 3/4 inches).
 - **TWO** identical passport photos produced from the same unretouched film or from the same file capturing the digital image. Must be original photos, not taken from any existing photo.
 - Show a full front view of head and shoulders without head covering.
 - Image must have the face square to the camera with a neutral expression and with the mouth closed.
 - Taken against a plain, uniform white or light coloured background. Photos with shadows on the face or background are not acceptable.
 - Tinted prescription glasses may be worn as long as the eyes are clearly visible. Sunglasses are not acceptable.
 - Taken within the last 12 months.
 - Must be on light weight paper; heavy weight paper is not acceptable.
 - Black and white or colour photos.
- Notarial seals must **not** be imprinted on photos. Photos produced digitally are acceptable provided all other requirements are met. Photos that do **not** meet these specifications or do **not** allow a clear and positive identification are **not** acceptable. Photos subject to premature fading or sensitive to heat, and group photos are **not** acceptable.



PHOTOGRAPHER'S INFORMATION

The name and address of the photographer and the date the photos were taken must appear on the back of **ONE** photo.

GUARANTOR'S DECLARATION

Your guarantor must certify and sign the back of one photo bearing the stamp of the photographer. If you do not have a guarantor and are completing a "Declaration in Lieu of Guarantor" form PPT 132, refer to specific instructions on the form.
